NO.PAS/LEGIS-B-14/2020- The Education City (Amendment) Bill, 2020 having been passed by the Provincial Assembly of Sindh on 23<sup>rd</sup> July, 2020 and assented to by the Governor of Sindh on 05<sup>th</sup> August, 2020 is hereby published as an Act of the Legislature of Sindh.

#### THE EDUCATION CITY (AMENDMENT) ACT, 2020

#### SINDH ACT NO. XIX OF 2020

#### AN ACT

to amend the Education City Act, 2013.

**WHEREAS** it is expedient to amend the Education City Act, 2013, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

1. (1) This Act may be called the Education City (Amendment) Act, 2020. **Short title and commencement.**
- (2) It shall come into force at once.
2. In the Education City Act, 2013, in section 3, for sub-section (2), the following shall be substituted:- **Amendment of section 3 of Sindh Act No.XVI of 2013.**
